

Ordinance 14-21

An Ordinance of Supplemental Appropriation for January 2021 Tribal Per Capita Distributions for Fiscal Year Ending September 30, 2021.

The District III Representative introduced the following Bill on the 16th day of December, 2020.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for January 2021 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2021.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for January 2021 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two million, six hundred seventy-three thousand, seven hundred twenty-four dollars and no cents (\$2,673,724.00) for Adult Distributions 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the January 2021 Tribal Per Capita Distributions under **Per Capita Distribution** which also amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: Forty-six million, two hundred forty-one thousand, five hundred forty-eight dollars and forty-nine cents (\$46,241,548.49).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:



Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for January 2021 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two million, six hundred seventy-three thousand, seven hundred twenty-four dollars and no cents (\$2,673,724.00) for Adult Distributions 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the January 2021 Tribal Per Capita Distributions under **Per Capita Distribution** which also amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: Forty-six million, two hundred forty-one thousand, five hundred forty-eight dollars and forty-nine cents (\$46,241,548.49).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
