

## Ordinance 11-21

An Ordinance of Supplemental Appropriation and Budget Revisions/Transfers for Community Development, Department of Justice, Education, Administration, Health & Human Services and Judicial for the Fiscal Year ending September 30, 2021.

The District III Representative introduced the following Bill on the 9<sup>th</sup> day of December, 2020.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and budget revisions/transfers for Community Development, Department of Justice, Education, Administration, Health & Human Services and Judicial for the Fiscal Year ending September 30, 2021.

### Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and budget revisions/transfers for Community Development, Department of Justice, Education, Administration, Health & Human Services and Judicial for the Fiscal Year ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Seventy thousand, six hundred fifty-two dollars and twenty-nine cents (\$70,652.29) for Elder Supplemental 107-2370-0 of FY2020 Elder Supplemental Revenue Funds as submitted under **Administration** which amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Two hundred forty-one million, six hundred thirty-two thousand, seventy-eight dollars and thirty-nine cents (\$241,632,078.39).

If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.05: All funds appropriated are maximum fund amounts and shall not be exceeded.
