## Ordinance 23-21

An Ordinance of supplemental appropriation for Mille Lacs Corporate Ventures for the Fiscal Year Ending September 30, 2021.

The District III Representative introduced the following Bill on the 27th day of January, 2021.

#### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for Mille Lacs Corporate Ventures for the Fiscal Year Ending September 30, 2021.

### Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Mille Lacs Corporate Ventures for the Fiscal Year Ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six hundred twelve thousand dollars and no cents (\$612,000.00) for Wewinabi (a subsidiary of Mille Lacs Corporate Ventures) of FY2021 Economic Development Funds to cover the operating costs of Wewinabi businesses and loan payments for Grindstone Laundry in the 1<sup>st</sup> quarter of Fiscal Year 2021 as submitted under Mille Lacs Corporate Ventures which amends the Total Fiscal Year 2021 Mille Lacs Band Tribal Operations to read: One hundred ninety-eight million, twenty-one thousand, three hundred twenty-six dollars and eighty-one cents (\$198,021,326.81).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

### Title I

The Band Assembly hereby appropriates and authorizes the expenditures of: Six hundred twelve thousand dollars and no cents (\$612,000.00) for Wewinabi (a subsidiary of Mille Lacs Corporate Ventures) of FY2021 Economic Development Funds to cover the operating costs of Wewinabi businesses and loan payments for Grindstone Laundry in the 1<sup>st</sup> – 4<sup>th</sup> quarters of Fiscal Year 2021 as submitted under **Mille Lacs Corporate Ventures** which amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: One hundred ninety-eight million, twenty-one thousand, three hundred twenty-six dollars and eighty-one cents (\$198,021,326.81).
