Ordinance 28-21

An Ordinance of Supplemental Appropriation and Budget Revisions/Transfers for Health & Human Services, Community Development, and Legislative for the Fiscal Year Ending September 30, 2021.

The District II Representative introduced the following Bill on the 10th day of March, 2021.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and budget revisions/transfers for Health & Human Services, Community Development, and Legislative for the Fiscal Year Ending September 30, 2021.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and budget revisions/transfers for Health & Human Services, Community Development, and Legislative for the Fiscal Year Ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two hundred forty-one thousand, five hundred sixty-five dollars and fifty cents (\$241,565.50) for Public Works IHS Grants of a Re-appropriation of FY2020 Permanent Initiative Funds for Band Match contributions to I.H.S. Grants as submitted; One hundred forty-six thousand, six hundred twenty-five dollars and fifty cents (\$146,625.50) for Public Works IHS Grants of a Re-appropriation of FY2020 Housing Initiative Funds for Band Match contributions to I.H.S. Grants as submitted under **Community Development**; Ninety-one thousand, one hundred forty-eight dollars and no cents (\$91,148.00) for DI Powwow 7200-101-1070-0 of a Re-appropriation of FY2020 Permanent Initiative Funds as submitted; Twenty-two thousand, seven hundred dollars and no cents (\$22,700.00) for DI Powwow 7200-101-1070-0 of FY2021 Permanent Initiative Funds as submitted under **Legislative** which amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: Two hundred four million, three hundred nine thousand, seven hundred sixty-five dollars and eleven cents (\$204,309,765.11).
