Ordinance 33-21

An Ordinance of Supplemental Appropriation and Budget Revisions for Education, Natural Resources, Health & Human Services, Administration and Community Development for the Fiscal Year Ending September 30, 2021.

The District III Representative introduced the following Bill on the 7th day of April, 2021.

Preamble

It is enacted by the Band Assembly of the Non-Removable Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and budget revision for Education, Natural Resources, Health & Human Services, Administration and Community Development for the Fiscal Year Ending September 30, 2021.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and budget revisions for Education, Natural Resources, Health & Human Services, Administration and Community Development for the Fiscal Year Ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Seventy-nine thousand, five hundred seventy-five dollars and no cents (\$79,575.00) for Aanjibimaadizing PL 102-477 of FY2021 Self-Governance Funds to be used on health & safety improvements, including a new well in District III, for Mille Lacs Band Head Start sites that provide child care as submitted under Administration; Sixty-five thousand, eight hundred sixty-three dollars and ten cents (\$65,863.10) for Food Distribution Equipment CARES Funding 223-4520-1 of FY2021Grant Funds to support the purchase of a new cargo van with proper food storage capacity and a new floor cleaning machine as submitted; One hundred twenty-five thousand dollars and no cents (\$125,000.00) for MN DHS Opioid Pilot Project 221-4129-2 of FY2021 Grant Funds to support time spent in weekly networking sessions by a provider or pharmacist through the ECHO Group for SUD as submitted; One hundred forty-four thousand, two hundred eighty-six dollars and no cents (\$144,286.00) for Special Diabetes Program for Indians (SDPI) 221-4150-1 of FY2021 Grant Funds as submitted; Six thousand, nine hundred eighty-six dollars and no cents (\$6,986.00) for Family Services Title IV-B Subpart 2 224-4870-1 of FY2021 Grant Funds as submitted under Health & Human Services; One million, five hundred thirty-five thousand, nine hundred forty dollars and no cents (\$1,535,940.00) for IHBG 271-2900-1 of FY2021 Grant Funds to support the Band's income based housing rental stock and all activities approved through the annual Indian Housing Plan for the fiscal year as submitted under Community Development which amends the Total Fiscal Year 2021 Mille Lacs Band Tribal Operations to read: Two hundred twenty-five million, one hundred thousand, four hundred sixty-six dollars and twenty-five cents (\$225,100,466.25).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified immediately so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.05: All funds appropriated are maximum fund amounts and shall not be exceeded. Funds must be utilized for the purposes identified herein.
