Ordinance 32-21

An Ordinance of Supplemental Appropriation and Budget Revisions for Administration, Department of Justice, Natural Resources, Education and Health & Human Services for the Fiscal Year Ending September 30, 2021.

The District II Representative introduced the following Bill on the 24th day of March, 2021.

Preamble

It is enacted by the Band Assembly of the Non-Removable Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and budget revision/ for Administration, Department of Justice, Natural Resources, Education and Health & Human Services for the Fiscal Year Ending September 30, 2021.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and budget revisions for Administration, Department of Justice, Natural Resources, Education and Health & Human Services for the Fiscal Year Ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2021. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified immediately so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.05: All funds appropriated are maximum fund amounts and shall not be exceeded. Funds must be utilized for the purposes identified herein.
