

Ordinance 07-21

An Ordinance of Supplemental Appropriation for December 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2021.

The District III Representative introduced the following Bill on the 18th day of November, 2020.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for December 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2021.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for December 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: One million, four hundred seven thousand, two hundred fifty dollars and no cents (\$1,407,250.00.00) for Adult Distributions 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the December 2020 Tribal Per Capita Distributions; Five hundred thirteen thousand, eight hundred twenty-five dollars and no cents (\$513,825.00) for Minor Distribution 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the December 2020 Tribal Per Capita Distributions under **Per Capita Distribution** which also amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: Twenty-three million, thirty-eight thousand, three hundred sixty-five dollars and twenty-one cents (\$23,038,365.21).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for December 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2021.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for December 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: One million, four hundred seven thousand, two hundred fifty dollars and no cents (\$1,407,250.00.00) for Adult Distributions 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the December 2020 Tribal Per Capita Distributions; Five hundred thirteen thousand, eight hundred twenty-five dollars and no cents (\$513,825.00) for Minor Distribution 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the December 2020 Tribal Per Capita Distributions under **Per Capita Distribution** which also amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: Twenty-three million, thirty-eight thousand, three hundred sixty-five dollars and twenty-one cents (\$23,038,365.21).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
