

COMMISSIONER'S ORDER 25-88

CORPORATE AFFAIRS

A Commissioner's Order to authorize the release and transfer of the first two cabins starting from west to east (cabins number one and two). The cabins are to be moved from the Mille Lacs Reservation Marina Tourism Complex to the Education Division at Ni Ah Shing School.

WHEREAS, under provisions of Band Statute 1032-MLC-1, Section 28, the Acting Corporate Commissioner shall have sole authority to administer, regulate, and authorize all business enterprises under the jurisdiction of the Band through Executive Order 054, and;

WHEREAS, the Acting Corporate Commissioner shall have the power to authorize, organize and reorganize all business related matters in the best interest of all Band Members for economic development, and;

WHEREAS, the Mille Lacs Reservation Marina Tourism Complex has not been in operation for approximately three years, and;

WHEREAS, the Education Division is desirous in utilizing and transferring cabins number one and two from the Marina Tourism Complex for additional class room space at the Ni Ah Shing School, District One, and;

WHEREAS, the Acting Corporate Commissioner has determined that in order to increase economic activity and relieve the slow deterioration of the building structures at the Marina Tourism Complex that the request of the Education Division be granted, and;

WHEREAS, the Acting Corporate Commissioner has received verbal concurrence through telephone communication with Corporate Board Members that the request of the Education Division be granted and the cabins be move, and;



NOW THEREFORE, pursuant to the authority vested in me by Band Statute 1032-MLC-1, Section 28, and Executive Order 054, 1, Raymond Kegg, Acting Corporate Commissioner of Corporate Affairs do hereby grant the request of the Education Division to remove and transfer cabins one and two at the Marina Tourism Complex to the Ni Ah Shing School area at District One for economic and educational purposes with all transporting and construction expenses paid by the Education Division.


BE IT FURTHER ORDERED, that the Commissioner of Education shall supervise the above operations and to secure the following conditions after the two building have been transferred for future safety precautions.

1. remove all debris from former existing foundations.  
(old concrete blocks, lumber, ect.,)
2. cap existing plumbing lines (water and sewer) and bury one foot below ground level.
3. cap electrical service to prevent electrical shock or power drain.
4. clear and landscape old sites to ground level.
5. after the two building are removed the gate entrance shall be restored to standard condition.
6. a plan be developed to sustain future operations of the buildings that are being moved.
