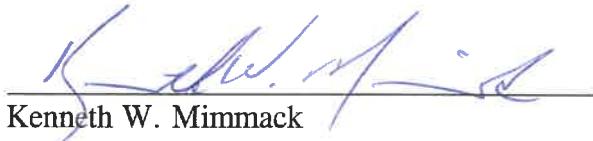
The undersigned, the Commissioner of Corporate Affairs of the Corporate Commission of the Mille Lacs Band of Ojibwe Indians, a corporation and a political subdivision of the Mille Lacs Band of Ojibwe Indians (the "Commission"), hereby adopts the following Corporate Order effective this 3rd Day of February, 2000.

WHEREAS, The Commission has the authority under 16 MLBSA § 106(e) to regulate gaming;

WHEREAS, The Commissioner of Corporate Affairs is empowered pursuant to 16 MLBSA § 111 (b) (1) to issue such regulations or take such directives as may be necessary to serve the best interest of the Commission via a Corporate Order;

NOW THEREFORE, the Commissioner of Corporate Affairs hereby adopts the Gaming Regulations, which are attached hereto as Exhibit A to this Order and made part hereof by reference thereto.
