

A COMMISSIONER'S ORDER TO TEMPORARILY  
EMPLOY DALLAS ANDERSON AS ROADS ASSISTANT

WHEREAS, Pursuant to 4 MLBSA section 7 (d), the Assistant Commissioner of Administration has the authority to regulate the performance of employees, including the hiring and dismissal of an employee; and

WHEREAS, Public Works is in need of the use of a temporary employee to perform duties, and

WHEREAS, the Assistant Commissioner of Administration is authorized to hire employee's for temporary positions until a specific job is complete; and

WHEREAS, due to the lack of personnel there is an urgent need for this temporary position, and

WHEREAS, the interview committee has recommended that Dallas Anderson be the temporary employee for this position.


