Commissioner's Order 251-09

A COMMISSIONER'S ORDER TO AUTHORIZE EXECUTION OF AN EMERGENCY SERVICE CONTRACT BETWEEN THE HEALTH AND HUMAN SERVICES DEPARTMENT AND WEATHERIZATION RESEARCH AND PRODUCTION, INC., PRIOR TO APPROVAL BY THE ADMINISTRATION POLICY BOARD.

WHEREAS, the Administration Policy Board is required to approve all Executive Branch contracts in excess of \$5000 pursuant to 7 MLBSA § 26(b)(3);

WHEREAS, in the event that the Administration Policy Board is unable to perform its duties due to a lack of quorum, the Commissioner of Administration may issue a Commissioner's Order, pursuant to 4 MLBSA § 9(a), to implement a matter until the Administration Policy Board is able to meet;

WHEREAS, the Health and Human Services Department received a grant from the State of Minnesota for weatherization of Band member homes which must be utilized before June 30, 2009 to prevent the Band from losing access to the funds;


WHEREAS, the HHS Department must enter into an emergency service contract with Weatherization Research and Production, Inc., in order to complete work on these weatherization projects before the grant deadline of June 30, 2009; and

WHEREAS, the Administration Policy Board is unable to hold an emergency session due to a lack of quorum.

NOW THEREFORE, be it ordered that the Commissioner of Health and Human Services, is authorized to execute an emergency service contract with Weatherization Research and Production, Inc., in an amount not to exceed \$24,900.00 to perform weatherization services.
