ADMINISTRATION COMMISSIONER'S ORDER 257-10

A COMMISSIONER'S ORDER TO AUTHORIZE EXECUTION OF AN EMERGENCY SERVICE CONTRACT BETWEEN THE COMMUNITY DEVELOPMENT DEPARTMENT AND NELSON-DEGERSTROM CONSTRUCTION, LLC, PRIOR TO APPROVAL BY THE ADMINISTRATION POLICY BOARD.

- WHEREAS,** the Administration Policy Board is required to approve all Executive Branch contracts in excess of \$5000 pursuant to 7 MLBSA § 26(b)(3);
- WHEREAS,** in the event that the Administration Policy Board is unable to perform its duties due to a lack of quorum, the Commissioner of Administration may issue a Commissioner's Order, pursuant to 4 MLBSA § 9(a), to implement a matter until the Administration Policy Board is able to meet;
- WHEREAS,** elder Gloria Anderson has health issues which have resulted in both the need for frequent emergency medical attention and an extreme reduction in her mobility;
- WHEREAS,** her restrictively narrow home construction, coupled with her crippling illness, has resulted in a lack of accessibility to her home by emergency medical staff and has severely increased the time it takes to transport her to the hospital;
- WHEREAS,** a home renovation will increase accessibility for medical staff and reduce the danger that she will not be seen by medical staff in time to prevent further harm to her health or worse;
- WHEREAS,** the Community Development Department must enter into an emergency service contract with Negerstrom-Degerstrom in order to begin work on these emergency repairs to Ms. Anderson's home as soon as possible to avoid another situation where she is unable to receive needed timely medical attention; and
- WHEREAS,** the Administration Policy Board is unable to hold an emergency session due to a lack of quorum.
- NOW THEREFORE,** be it ordered that the Commissioner of Community Development, is authorized to execute an emergency construction contract with Nelson-Degerstrom in an amount not to exceed \$47,050.00 to make necessary renovations at Ms. Anderson's home.


