Commissioner's Order 282-13

A COMMISSIONER'S ORDER TO ENGAGE THE SERVICES OF NICOLE GRABOW OF MIDWEST ART CONSERVATION CENTER

WHEREAS, Pursuant to Title 4 MLBSA §10(g) the Assistant Commissioner of Administration possesses the authority of the Commissioner of Administration in his/her absence; and

WHEREAS, Pursuant to Title 4 MLBSA §9(a) the Assistant Commissioner of Administration may act on behalf of the Administration Policy Board in the event such entity cannot obtain a quorum to conduct its delegated affairs; and

WHEREAS, The services of Nicole Grabow of Midwest Art Conservation Center are necessary in order for the Mille Lacs Band of Ojibwe to timely and successfully assist the Natural Resources department in providing individual condition assessment reports of approximately 227 ethnographic objects of the Sherman Holbert Collection in storage at the Mille Lacs Indian Museum in Vineland, Minnesota; and

WHEREAS, Approval of a Service Contract by the Administration Policy Board prior to the time Nicole Grabow of Midwest Art Conservation Center must begin work is highly unlikely due to the inability of the Administration Policy Board achieving a quorum by the needed date of the start of services; and

WHEREAS, Payment for the services of Nicole Grabow of Midwest Art Conservation Center will not be made until after the next Administration Policy Board meeting;

NOW THEREFORE IT IS ORDERED that Nicole Grabow of Midwest Art Conservation Center will be hired by the Mille Lacs Band to provide individual condition assessment reports of approximately 227 ethnographic objects of the Sherman Holbert Collection in storage at the Mille Lacs Indian Museum in Vineland, Minnesota.
