Commissioner's Order 287-18

A COMMISSIONERS ORDER REQUIRING ALL DEPARTMENTS TO ADHERE TO AND TO UTILIZE THE POLICIES, PROCEDURES, AND FORMS OF THE GRANTS DEPARTMENT WHEN SUBMITTING NEW AND RENEWED GRANT APPLICATIONS TO OUTSIDE AGENCIES ON BEHALF OF THE MILLE LACS BAND.

WHEREAS, Pursuant to Title 4 MLBSA §7(h) the Commissioner of Administration has the authority to issue an order on any subject matter within their jurisdiction pursuant to authority conferred by Band Statute; and

WHEREAS, Pursuant to Title 4 MLBSA §7(i) the Commissioner of Administration has the authority to take measures deemed necessary to prevent any action which threatens the well-being of programs within their respective jurisdiction; and

WHEREAS, Pursuant Title 4 MLBSA §7(g) the Commissioner of Administration has the authority to prescribe procedures for the development of policy in the area under their respective jurisdiction; and

WHEREAS, Pursuant to Title 4 MLBSA §10(g) the Assistant Commissioner of Administration possesses the authority of the Commissioner of Administration in his/her absence; and

NOW THEREFORE IT IS ORDERED that all departments will submit the necessary forms, data, and information to the Grants Department in accordance with the departments policies and procedures. It is the responsibility of the Directors and Commissioners to ensure compliance with the processes of the Grants Department.
