## Commissioner's Order 286-18

A COMMISSIONERS ORDER ESTABLISHING MANDATORY ATTENDANCE OF ALL PROGRAM DIRECTORS AT THE QUARTERLY MIDDLE MANAGEMENT MEETINGS CONDUCTED BY THE HUMAN RESOURCE DEPARTMENT.

WHEREAS, Pursuant to Title 4 MLBSA §7(h) the Commissioner of Administration has the authority to issue an order on any subject matter within their jurisdiction pursuant to authority conferred by Band Statute; and

WHEREAS, Pursuant to Title 4 MLBSA §7(i) the Commissioner of Administration has the authority to take measures deemed necessary to prevent any action which threatens the well-being of programs within their respective jurisdiction; and

WHEREAS, Pursuant Title 4 MLBSA §7(g) the Commissioner of Administration has the authority to prescribe procedures for the development of policy in the area under their respective jurisdiction; and

WHEREAS, Pursuant to Title 4 MLBSA §10(g) the Assistant Commissioner of Administration possesses the authority of the Commissioner of Administration in his/her absence; and

**NOW THEREFORE IT IS ORDERED** that the quarterly Middle Management meetings are mandatory meetings for all programs directors, in the instances where program directors are unable to attend due to unforeseen circumstances, funding agency meetings/trainings, or prior authorized leave, the program director will ensure that a member of his/her department is present.
