A COMMISSIONER'S ORDER TO AUTHORIZE EXECUTION OF AN APPROPRIATION OF GRANT FUNDS PRIOR TO APPROVAL BY THE ADMINISTRATION POLICY BOARD TO BE FORWARDED TO BAND ASSEMBLY

WHEREAS, Pursuant to Title 4 MLBSA §10(g) the Assistant Commissioner of Administration possesses the authority of the Commissioner of Administration in his/her absence; and

WHEREAS, Pursuant to Title 4 MLBSA §9(a) the Assistant Commissioner of Administration may act on behalf of the Administration Policy Board in the event such entity cannot obtain a quorum to conduct its delegated affairs; and

WHEREAS, the Administration Policy Board approves all requests for appropriation of funds to forward to Band Assembly for approval; and

WHEREAS, the Mille Lacs Band Boys & Girls Club department requires an immediate appropriation of grant funds to execute expenditure of funds within the guidelines of the grant funding agency; and

NOW THEREFORE, be it ordered that the appropriation request dated 7/11/2013, authorizing an increase in the MLB Boys & Girls Club budgets #201-304-4300 by \$1,875.00; #201-309-6800 by \$1,875.00; #201-317-6400 by \$1,875.00; and #201-319-4300 by \$1,875.00, for a total appropriation of \$7,500.00, be executed immediately.
