Commissioner's Order 264-13

A COMMISSIONER'S ORDER TO AUTHORIZE EXECUTION OF A BUDGET MODIFICATION PRIOR TO APPROVAL BY THE ADMINISTRATION POLICY BOARD

WHEREAS, Pursuant to Title 4 MLBSA §10(g) the Assistant Commissioner of Administration possesses the authority of the Commissioner of Administration in his/her absence; and

WHEREAS, Pursuant to Title 4 MLBSA §9(a) the Assistant Commissioner of Administration may act on behalf of the Administration Policy Board in the event such entity cannot obtain a quorum to conduct its delegated affairs; and

WHEREAS, the Administration Policy Board approval all budget modifications over \$10,000.00; and

WHEREAS, the Governmental Affairs department requires an immediate budget modification in order to cover deficit amounts within the budget; and

NOW THEREFORE, be it ordered that the budget modification dated 7/10/2013 authorizing an increase in the following line items of the Governmental Affairs budget; #100-226-4000 by \$55,000.00; #100-226-4107 by \$1,000.00; #100-226-4109 by \$400.00; #100-226-4110 by \$625.00; #100-226-4111 by \$625.00; #100-226-4112 by \$4,500.00; #100-226-4300 by \$1,100.00 and decreasing the following line items of the Governmental Affairs budget; #100-226-445 by \$16,000.00; #100-226-5000 by \$2,750.00; #100-226-6300 by \$2,000.00; #100-226-6500 by \$17,500.00; and #100-226-6800 by \$25,000.00 for a total budget revision in the amount of \$63,250.00 to be executed immediately.
