## Commissioner's Order 001-07

A COMMISSIONER ORDER TO ENSURE THE CONTINUED CONSTRUCTION OF THE MINISINAAKUAANG LEADERSHIP ACADEMY IN EAST LAKE BY AUTHORIZING THE TEMPORARY EMPLOYMENT OF BAND MEMBER WORKERS TO CONTINUE UNTIL COMPLETION OF THE PROJECT EFFECTIVE MAY 11<sup>TB</sup>, 2007.

- WHEREAS, pursuant to Title 13, Chapter 2, the Commissioner of Community

  Development has the authority to provide technical assistance to other
  departments, and
- WHEREAS, the Commissioner of Community Development has the responsibility of providing general oversight on construction projects on the Reservation and on lands owned by entities of the Mille Lacs Band of Ojibwe, and
- WHEREAS, this includes the responsibility to promote the principles, practices and policies that ensure that Band members have the maximum opportunity to participate in employment opportunities on Band construction projects now and into the future, and
- WHEREAS, circumstances have arisen whereby the contractor responsible for construction of the Minisinaakuaang Leadership Academy in East Lake.

  Minnesota, has not been able to maintain the workers needed to complete the job, and
- WHEREAS, it is imperative that the Minisinaakuaang Leadership Academy be completed, and
- WHEREAS. Community Development has, therefore, continued the employment of the Band member workers previously working for the contractor as temporary employees of the Band, and
- WHEREAS, the completion of the Minisinaakuaang Leadership Academy depends on the continued employment of these temporary workers beyond the time frame usually allowed for temporary workers of the Band.
- NOW THEREFORE, be it ordered that the temporary workers retained by Community Development for completion of the Minisinaakuaang Leadership Academy shall be retained and authorized to work in a temporary capacity until the Minisinaakuaang Leadership Academy is completed.
