COMMISSIONER'S ORDER NO. ~~24-85~~

NATURAL RESOURCES

A Commissioner's Order establishing interim policies, responsibilities and directives.

WHEREAS: Executive Order No. 041 recinds and repeals Executive No. 016; and,

WHEREAS: Executive Order No. 041 transfers responsibilities of law enforcement operation to the Commissioner of Natural Resources; and,

WHEREAS: Band Statute 1032-MLC-1, Section 29 directs Commissioners of the Band to take such measures as are necessary to protect the well being of programs; and,

WHEREAS: The reorganization of the law enforcement department will be completed; and,

WHEREAS: The interim policies, responsibilities and directives are to be established by the Commissioner of Natural Resources.

NOW THEREFORE, by the authority vested in me by the Mille Lacs Band of Chippewa Indians under tribal law, I, Don Wedl, Commissioner of Natural Resources for the Mille Lacs Band of Chippewa Indians, hereby order the following:

1. The first priority for law enforcement officers will be the completion of quarterly reports:

July through September, 1984

October through December, 1984

and annual reports:

October, 1983 through September, 1984

A combined effort by law enforcement officers will be done so that these reports are in the Commissioner of Natural Resources Office by March 6, 1985. Failure to have these past reports completed will result in a minimum of 3 days suspension without pay. Law Officer Gene Reynolds will compile individual law enforcement officer reports and insure all three reports are completed by March 6, 1985.

2. All law enforcement officers will fill out time sheets that relate to the time and hours worked, starting March 4, 1985 and continuing thereafter.

3. Each law enforcement officer will submit to the Commissioner of Natural Resources the following weekly information:
 - a. the number of calls that officers received that week. This may be: telephone calls, letters, or person to person requests.
 - b. the number of different investigation worked on during the past week and total time worked.
 - c. The total number of miles logged during the week.
 - d. The number of citations issued.
 - e. The number of citations or arrests made.
 - f. The number of pending citations or arrests.
 - g. The number of hours in office.
 - h. The number of hours working with the court.

This information is due each thursday.

4. No investigation by law enforcement officers will be done without the written approval of the Chief Executive, delegated to the Commissioner of Natural Resources, unless in an emergency situation.
5. No law enforcement officer will use their uniform, or equipment when they are not on duty. When on duty all officers shall be in full uniform.
6. Each law enforcement officer shall complete an inventory of the equipment assigned to them. This will be done by March 8, 1985.
7. In this interim period and in the absence of total personnel policies for law enforcement officers, the Mille Lacs Band of Chippewa Indians Programmatic Personnel Policies established September 2, 1982, and amendments shall be applicable.
8. All law enforcement officers will report to work at the Mille Lacs Reservation Government Center at 8:00 a.m. March 6, 1985 to review quarterly reports and the interim development of the law enforcement department.


9. The following work schedule will be in effect until March 6, 1985:
