

**COMMISSIONER'S ORDER NO. 45-86**  
**Natural Resources**

A Commissioner's Order to regulate the opening and closing of the Mille Lacs Band of Chippewa hunting seasons for the year 1986.

WHEREAS, the Commissioner of Natural Resources has the power to open and close hunting seasons within the jurisdiction of the Mille Lacs Band of Chippewa, through Band Statute 1032-MLC-1, Section 29; and,

WHEREAS, the Spiritual Advisor and the Commissioner of Natural Resources for the Mille Lacs Band of Chippewa Indians concur that the seasons should be open; and,

WHEREAS, the hunting of animals or birds should be done with preservation of the species foremost; and,

NOW THEREFORE, pursuant to the authority vested in me by the Mille Lacs Band of Chippewa Indians, pursuant to Band Statute 1032-MLC-1, Section 29, I, Don Wedl, Commissioner of Natural Resources, with the concurrence of the Spiritual Advisor, establish the following hunting season effective for the year 1986.




