Certificate of Correctness

- WHEREAS, on January 21, 1998, the Non-Removable Mille Lacs Band of Ojibwe Band Assembly (“Band Assembly”) approved Ordinance 17-98;
- WHEREAS, according to 3 MLBS § 17(c), the Chief Executive has five calendar days to either sign the bill into law or veto the bill.
- WHEREAS, according to James Genia, the Solicitor General at the time, the Chief Executive took no action within the five calendar days, which resulted in Ordinance 17-98 becoming law.
- WHEREAS, on October 11, 2005, the Band Assembly approved Ordinance 03-06, which amended Title 7 to more specifically outline the guidelines for bonding requirements of construction projects;
- WHEREAS, on October 14, 2005, the Chief Executive signed into law Ordinance 03-06;
- WHEREAS, on November 12, 2009, the Band Assembly approved and the Chief Executive signed into law Ordinance 44-09, which amended 7 MLBS § 26;
- WHEREAS, on January 23, 2014, the Band Assembly approved Ordinance 15-14, which amended 7 MLBS § 21;
- WHEREAS, on January 27, 2014, the Chief Executive signed into law Ordinance 15-14;
- WHEREAS, on November 12, 2019, the Band Assembly approved Ordinance 09-20, which amended 7 MLBS §§ 10, 16;
- WHEREAS, on November 13, 2019, the Chief Executive signed into law Ordinance 09-20;
- WHEREAS, on October 27, 2021, the Band Assembly approved Ordinance 07-22, which amended 7 MLBS §§ 10, 16, 17, 26;
- WHEREAS, on October 28, 2021, the Chief Executive signed into law Ordinance 07-22;


