EXECUTIVE ORDER NO. 130-00

**AN EXECUTIVE ORDER EXTENDING THE TERMS
OF THE CONSOLIDATED NAY-AH-SHING
SCHOOL BOARD CHAIRPERSON FRANCIS DAVIS
AND SCHOOL BOARD MEMBERS MARY SUE
BOHANON AND LOUISE BOYD-DAY TO ALLOW
FOR A SPECIAL ELECTION**

WHEREAS, Pursuant to 4 MLBSA § 6(e), the Chief Executive is authorized to issue Executive Orders on any subject matter within the Executive Branch of government pursuant to the authority conferred by Band Statute; and

WHEREAS, Pursuant to 4 MLBSA § 6(b), the Chief Executive is authorized to make appointments to commissions, boards or authorities and to fill any vacancy in any office as authorized by Band Statute, and

WHEREAS, Pursuant to 9 MLBSA §§ 7(b) and (c), the Chief Executive shall nominate and forward to the Band Assembly for ratification the name of a person to fill any vacancy on the Consolidated Nay-Ah-Shing School Board, to include a vacancy in the position of Chairperson; and

WHEREAS, Pursuant to 9 MLBSA § 4, the terms of office for the Consolidated Nay-Ah-Shing School Board Chairperson Francis Davis and School Board members Mary Sue Bohanon and Louise Boyd-Day are set to expire on June 30, 2000; and

WHEREAS, The positions of Consolidated Nay-Ah-Shing School Board Chairperson and the School Board members referenced above will become vacant and remain vacant until an election is held; and

WHEREAS, Pursuant to 4 MLBSA §§ 4 and 7(i), the Chief Executive is authorized to take such measures as she deems necessary to prevent any harm from occurring to any program under her jurisdiction, and

WHEREAS, Francis Davis, Mary Sue Bohanon and Louis Boyd-Day have served effectively as Chairperson and members of the Consolidated Nay-Ah-Shing School Board.


NOW THEREFORE, IT IS HEREBY ORDERED that the terms of Consolidated
