EXECUTIVE ORDER 142-02

**AN EXECUTIVE ORDER TO AUTHORIZE DUANE DUNKLEY, THE COMMISSIONER OF
EDUCATION, TO REVIEW ORGANIZATION OF ALL EDUCATIONAL FUNCTIONS
PERFORMED BY THE MILLE LACS BAND OF OJIBWE AND TO MAKE AN APPROPRIATE
REPORT**

WHEREAS, 4 MLBSA § 6(b) authorizes the Chief Executive to appoint executive officers, and;

WHEREAS, 4 MLBSA § 4 identifies the Commissioner of Education as an executive officer, and;

WHEREAS, 9 MLBSA § 1 identifies the Nay-Ah-Shing School Board as an independent subdivision of the Executive Branch of tribal government, and;

WHEREAS, 9 MLBSA § 9 requires the Nay-Ah-Shing School Board to prepare an educational state of the Band report to the Chief Executive and biannually conduct a needs assessment into all areas of its jurisdiction, and;

WHEREAS, 4 MLBSA § 7(d) authorizes the Chief Executive to regulate the performance of the duties of executive officers, and;

WHEREAS, 4 MLBSA § 7(g) authorizes the Chief Executive to prescribe procedures for the development of policy, and;

WHEREAS, with Executive Order 108-93 the management structure of the Education Department was addressed by the Chief Executive, and;

WHEREAS, it is necessary and prudent to periodically review the performance of Band government operations and such a review is within the duties of the Chief Executive in accordance with 4 MLBSA §§ 6(a) and 7(a), and;

NOW THEREFORE, IT IS ORDERED, that Duane Dunkley, the Commissioner of Education is hereby appointed and authorized to conduct a review and to study all educational operations administered by the Mille Lacs Band of Ojibwe.

BE IT FURTHER ORDERED, that the work of Duane Dunkley, the Commissioner of Education shall commence the review and study of educational operations pursuant to a schedule and deadline established by the Chief Executive.

BE IT FURTHER ORDERED, that the Commissioner of Education, the Nay-Ah-Shing School Board, and all Band education employees shall provide assistance to Commissioner Dunkley, so as to facilitate his timely and efficient completion of its duties.

BE IT FINALLY ORDERED, that Duane Dunkley, the Commissioner of Education, shall periodically report his activities and progress to the Chief Executive.


