EXECUTIVE ORDER 152-07

An Executive Order Appointing Sara Oquist to chair the Administration Policy Board on October 31, 2007.

- WHEREAS**, pursuant to 4 MLBSA § 6(e), the Chief Executive is authorized to issue Executive Orders on any subject matter within the Executive Branch pursuant to the authorities conferred by Band Statute; and
- WHEREAS**, pursuant to 4 MLBSA § 6(b), the Chief Executive is authorized to fill any vacancy in any office as authorized by band statute including the heads of boards; and
- WHEREAS**, pursuant to 4 MLBSA § 8, the Administration Policy Board is an entity within the Executive Branch; and
- WHEREAS**, pursuant to 4 MLBSA § 4 and § 7(1), the Chief Executive is authorized to take such measures as she deems necessary to prevent any harm from occurring to any program under her jurisdiction; and
- WHEREAS**, The Commissioner of Administration and the Commissioner of Education must recuse themselves from chairing or voting at the Administration Policy Board meeting on October 31, 2007 in the interest of providing a fair hearing; and
- WHEREAS**, due to these recusals, a qualified person must be appointed temporarily to chair the hearing on October 31, 2007.
- NOW THEREFORE, BE IT RESOLVED**, that Commissioner of Corporate Affairs, Sara Oquist, is hereby appointed to Chair the Administration Policy Board for the hearing scheduled for October 31, 2007.
- BE IT FURTHER RESOLVED**, that this appointment shall end once the Administration Policy Board adjourns on October 31, 2007.




