EXECUTIVE ORDER 123-98

An Executive Order Appointing Lester Morris Acting Commissioner of Community Development.

WHEREAS, pursuant to Mille Lacs Band Statute 4 MLBSA § 6(e), the Chief Executive is authorized to issue Executive Orders on any subject matter within the Executive Branch pursuant to the authorities conferred by Band Statute; and,

WHEREAS, pursuant to Mille Lacs Band Statute 4 MLBSA § 4 and § 7(d), the Chief Executive is authorized to regulate the job performance of all persons employed within her area of subject matter jurisdiction; and,

WHEREAS, pursuant to Mille Lacs Band Statute 4 MLBSA § 6(b), the Chief Executive is authorized to appoint Commissioners, including the Commissioner of Community Development, subject to Band Assembly confirmation; and,

WHEREAS, a committee was formed to interview candidates for the Commissioner of Community Development position and recommend a nominee to the Chief Executive; and,

WHEREAS, the interview committee has unanimously recommended Lester Morris for the position of Commissioner of Community Development; and,

WHEREAS, the Chief Executive nominated Lester Morris and the Band Assembly vote to confirm this nomination resulted in a tie; and,

WHEREAS, pursuant to 4 MLBSA § 4 and § 7(l), the Chief Executive is authorized to take such measures as she deems necessary to prevent any harm from occurring to any program under her jurisdiction; and,

WHEREAS, the Commissioner of Community Development position is vacant and will
