**EXECUTIVE ORDER 128-00**

**AN EXECUTIVE ORDER APPOINTING TODD M. ROEN  
ACTING SOLICITOR GENERAL.**

- WHEREAS,** Pursuant to 4 MLBSA § 6 (e), the Chief Executive is authorized to issue Executive Orders on any subject matter within the Executive Branch of government pursuant to the authority conferred by Band Statute;
- WHEREAS,** Pursuant to 4 MLBSA § 4 and § 7 (d), the Chief Executive is authorized to regulate the job performance of all persons employed within her area of subject matter jurisdiction; and
- WHEREAS,** Pursuant to 4 MLBSA § 6 (b), the Chief Executive is authorized to appoint legal counsel and to make appointments to fill any vacancy in any office as authorized by Band Statute; and
- WHEREAS,** Pursuant to 4 MLBSA § 17 (a), the Chief Executive shall nominate and forward to the Band Assembly for confirmation the name of a competent and duly qualified individual of high honor and integrity to serve as the Solicitor General of the Non-Removable Mille Lacs Band of Ojibwe Indians; and
- WHEREAS,** Pursuant to 4 MLBSA § 17 (b), the appointment of former Solicitor General Adam H. Altman has expired on May 19, 2000 due to his resignation;
- WHEREAS,** The position of Solicitor General is vacant and will remain so until the Chief Executive nominates, and the Band Assembly confirms, a Solicitor General;
- WHEREAS,** Pursuant to 4 MLBSA § 4 and § 7 (i), the Chief Executive is authorized to take such measures as she deems necessary to prevent any harm from occurring to any program under her jurisdiction; and
- WHEREAS,** Todd M. Roen has served effectively as the Deputy Solicitor General for the Mille Lacs Band.


