Executive Branch of Tribal Government

Executive Order 107-93

An Executive Order Restricting Access To Tribal Lands In Order To Insure Public Safety And Preserve The Peace.

WHEREAS, pursuant to Mille Lacs Band Statute 1142-MLC-3, Section 7.05, the Chief Executive has the authority to issue Executive Orders on any subject matter within the Executive Branch pursuant to the authorities conferred by Band Statute; and,

WHEREAS, pursuant to Mille Lacs Band Statute 1142-MLC-3, Section 7.06, the Chief Executive acts as custodian for all Band property; and,

WHEREAS, several individuals have indicated an intent to spear fish on Mille Lacs Lake in violation of Band Law; and,

WHEREAS, if these individuals spear fish from Band lands they will be attempting to assert an off-reservation treaty right within the jurisdiction of the Mille Lacs Reservation; and,

WHEREAS, there exists a grave potential for violence and confrontation as a result of such conduct creating concern for public safety and preservation of the peace within the Mille Lacs Reservation; and,

WHEREAS, the Mille Lacs Band has sole and exclusive jurisdiction over tribal lands within the boundaries of its reservation.

NOW THEREFORE, BE IT ORDERED, that in order to protect the public safety and preserve the peace within the jurisdiction of the Mille Lacs Band, the following tribal lands will be closed to public use from April 20th, 1993, through May 15, 1993:

Kathio TWP. T43N R27W Sections 16, 21, 27, E 1/2 of 28, 33;
Kathio TWP. T42N R27W Section 3;

excluding persons lawfully conducting business with the Band government at a governmental facility.

BE IT FURTHER ORDERED, that Tribal Police and Conservation Officers and State Certified Peace Officers acting pursuant to a mutual aid agreement with the Band are authorized to arrest and cite violators of this Executive Order for trespass.


KATHIO TWP. NORTH
