LEGISLATIVE ORDER No. 021

SPECIAL RULE OF ORDER No. 1.

WHEREAS, pursuant to 3 MLBSA sec. 1, all legislative political authority of the Mille Lacs Band of Ojibwe is vested in the Legislative Branch of government;

WHEREAS, pursuant to 3 MLBSA sec. 11, the Band Assembly shall establish the rules of its proceedings (and) decide on its adjournment;

WHEREAS, pursuant to 3 MLBSA sec. 27(a) the Band Assembly may issue Legislative Orders on any subject matter within the Legislative Branch of government pursuant to authority conferred by this Title and the Constitution of the Minnesota Chippewa Tribe;

WHEREAS, pursuant to 3 MLBSA sec. 9, all parliamentary decisions shall be rendered in an impartial manner and be in accordance with Robert's Rules of Order;

WHEREAS, Robert's Rules of Order Revised, section 2, p. 12, states that "[w]hen a society or an assembly has adopted a particular parliamentary manual – such as this book – as its authority, the rules contained in that manual are binding upon it in all cases where they are not inconsistent with the bylaws or any special rules of order of the body...";

WHEREAS, Robert's Rules of Order Revised, section 2, p. 12, states that "[s]pecial rules of order supersede any rules in the parliamentary authority with which they conflict.";

WHEREAS, Robert's Rules of Order Revised, section 8, p. 76 states that "[s]pecial rules of order which do deal with parliamentary procedure...require both previous notice and a two-thirds vote for amendment.";

NOW THEREFORE, LET IT BE ORDERED THAT, a motion to place any proposed statute, order, resolution, or contract on the table for discussion can survive adjournment of a session of the Band Assembly and come over from such adjourned session to the next special session or regular session of the Band Assembly. Such order shall be retroactive to April 30th, 2002.






