LEGISLATIVE ORDER 36-22

**A LEGISLATIVE ORDER ESTABLISHING A UNIFORM SYSTEM OF NUMBERING
FOR LEGISLATIVE ORDERS**

WHEREAS, pursuant to 3 MLBS § 3(a), the Non-Removable Mille Lacs Band of Ojibwe Band Assembly possesses the power to “enact laws which promote the general welfare of the people[;]” and

WHEREAS, pursuant to 3 MLBS § 3(g), the Band Assembly possesses the power to “perform all other legislative functions conferred by the provisions of Article VI of the Constitution of the Minnesota Chippewa Tribe[;]” and

WHEREAS, pursuant to 3 MLBS § 30, the Band Assembly “may issue Legislative Orders on any subject matter within the Legislative Branch of government pursuant to authority conferred by this Title and the Constitution of the Minnesota Chippewa Tribe[;]” and

WHEREAS, pursuant to 3 MLBS § 30(b), “[a]ll . . . Legislative Orders shall be consecutively numbered[;]” and

WHEREAS, since 1986, Legislative Orders have been subject to at least two different systems of numbering; and

WHEREAS, since 2020, Legislative Orders have been numbered using the consecutive number, a dash, and the last two digits of the fiscal year in which the Legislative Order was adopted.

NOW, THEREFORE, BE IT ORDERED, that the Band Assembly hereby establishes a uniform system of numbering for Legislative Orders.

BE IT FURTHER ORDERED, that the numbering for each Legislative Order shall be as follows: the consecutive number, a dash, and the last two digits of the fiscal year in which the Legislative Order was adopted (e.g., Legislative Order 33-21).

BE IT FURTHER AND FINALLY ORDERED, that said uniform system of numbering shall not apply retroactively to any Legislative Order issued prior to Legislative Order 27-20.


