## **MESHAKWAD COMMUNITY CENTER STANDARDS**

1. AUTHORIZATION. Pursuant to 3 Mille Lacs Band Statutes Annotated section 8(a)(6), the District Representatives have the power and duty "[t]o authorize the use of district community centers according to written standards that are fair and reasonable." Therefore, the District III Representative authorizes the use of the District III Meshakwad Community Center according to the following standards.
2. GENERAL POLICIES
  - A. No guns or weapons allowed on property
  - B. No smoking, chewing tobacco or illegal drugs allowed on property
  - C. Violence of any kind and using foul language is prohibited
  - D. Chewing gum is not allowed in the Center
  - E. Only CLEAN athletic shoes are allowed on the gym floor, fitness area and golf simulator room
  - F. Children under 16 years of age must be accompanied and supervised by an adult while on property
  - G. Glass containers are not allowed on property
  - H. Be respectful of staff, property and guests
3. GOLF SIMULATOR ROOM
  - A. Reservations required
  - B. Fees paid prior to use
  - C. Must be 16 years old or older
  - D. Golf clubs not provided
  - E. Golf spikes not allowed
  - F. No food or drink allowed
4. KITCHEN AND PARTY
  - A. Reservations required along with signed rental agreement and paid security deposit for all non-band member parties
  - B. Security deposit amount is at the discretion of site manager. (Band Members amount = \$20 per reservation)
  - C. Rental agreement to state that entire area and equipment will be thoroughly cleaned by reservation party immediately after use
  - D. Children under 12 years old must have adult supervision
  - E. No sitting on counters
5. MEETING AND RECREATION ROOMS
  - A. Reservations required along with signed rental agreement and paid security deposit
  - B. Rental party must clean up immediately after use
6. LOCKER ROOM
  - A. Some lockers can be rented. For daily use, guests may bring their own lock and remove after
  - B. No audio visual or recording devices allowed. Cellphones must be OFF
  - C. Keep area clean

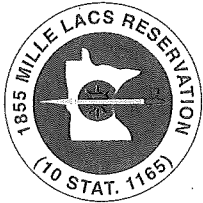

## OFFICE SPACE USES

1. Gymnasium must be reserved with Site Manager or District Representative. We would appreciate if anyone using gym have gym shoes or socks to preserve floor.
2. Room/Offices #142 and #143 are for Tribal Police. Presently using room 115 temporarily.
3. Room/Offices #112 and #113 are ear-marked for Headstart and/or Daycare program for employed parents as priority.
4. Room/Office #117 is for Band Assembly meetings. Can also be reserved for recording of drum songs, story-telling, etc.
5. Room #140 is designated for ITV college classes.
6. Room #139 is for exercise room (Zumba class, e.g.) or extra activities.
7. Room #136, Golf Simulator room, is by reservation only. Contact site manager or District Representative.
8. Exercise Equipment use is for membership only, non band member and band members. There shall be two days designated for Band Members only.
9. Party room should be pre-authorized and scheduled in advance.
10. Boxing Area (upstairs) will remain closed off to public. SEE Boxing area room/equipment page.

## GENERAL RULES

All Band Members may utilize the Community Center weight room for a \$10 lifetime fee, under 18 years old are free as well as MLB Elders.

Tribal Police are prohibited from arresting or harassing any Band Member on the Meshakwad property unless person is intoxicated and disruptive and are called by anyone on property. If they have a felony warrant, they may otherwise be arrested.

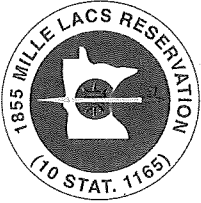

**BOXING AREA/ROOM/EQUIPMENT**

1. Boxing area and space is restricted from any recreational use. Injuries are frequent and dangerous. Serious injuries are common and numerous.
2. All coaches must be registered with USA Boxing and must successfully complete and pass the USA Boxing and SafeSport tests.
3. All boxers must be registered with USA Boxing.
4. USA Boxing insures all members and has strict rules to follow, which ensures safety for all members.
5. If any person (s) violate the rules of the boxing area, they will be subject to loss of privileges of the Meshakwad Center, including exclusion from the property.
6. The Head Coach will determine if there are any violations in this area and report to the Site Manager. The Site Manager will also ensure all the rules are adhered to when a boxing coach is not on site.
