RESOLUTION 20-02-31-22

A RESOLUTION IDENTIFYING ALL OF THE NAMES BY WHICH THE MILLE LACS BAND OF OJIBWE IS, HAS BEEN, OR MIGHT HAVE BEEN KNOWN

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected legislative body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian tribe; and

WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the power to adopt resolutions; and

WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and

WHEREAS, the Band’s Commissioner of Finance, who is also the Vice-Chairperson of the Band’s Institutional Investment Committee, has requested some form of formal clarification as to the names by which the Band is or has been known in order to facilitate the work of the Institutional Investment Committee; and

WHEREAS, the Band Assembly wishes to aid the Institutional Investment Committee in the efficient conduct of its business.
