RESOLUTION 20-02-33-22

A RESOLUTION CANCELLING RESOLUTION 17-01-69-16 FOR MILLE LACS BAND MEMBER [REDACTED]

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected legislative body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian tribe; and

WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the power to adopt resolutions; and

WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and

WHEREAS, tribal land leases are required on all Band lands for agricultural purposes, to establish home sites or seasonal recreational residences, for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 17-01-69-16, dated April 19, 2016, authorized a residential land lease to Band Member [REDACTED]; and

WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract #410TF000056, Government Lot Four (4) and the Southwest Quarter of the Southwest Quarter (SW ¼ of SW¼) of Section Twenty-one (21), Township Forty-three North (43N), Range Twenty-seven West (27W), Fourth Principle Meridian, Mille Lacs County, Minnesota, described as follows:

Lot Eight (8), Block Two (2) of North Connection Plat, containing one (1) acre, more or less[;]

and

WHEREAS, Band Member [REDACTED] has voluntarily relinquished the lease for the property described herein.
