RESOLUTION 20-01-11-22

A RESOLUTION IN SUPPORT OF THE APPOINTMENT OF RACHEL SHAUGOBAY TO THE MINNESOTA INDIAN CHILD WELFARE ADVISORY COUNCIL

- WHEREAS, the Non-Removable Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-removable Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBSA § 3(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Band Assembly has established as a priority the improvement of spiritual, physical, mental, social, and economic well-being of the people of the Band; and
- WHEREAS, the Minnesota Indian Child Welfare Advisory Council requires a resolution from the Band supporting the appointment of their Tribal representative to the Council; and
- WHEREAS, each Tribe in Minnesota has a seat on the Minnesota Indian Child Welfare Advisory Board; and
- WHEREAS, on January 21, 2022, the Commissioner of Health & Human Services, Nicole Anderson, requested the support of Band Assembly to seat Rachel Shaugobay, Director of Family Services for the Band, on the Minnesota Indian Child Welfare Advisory Board via the adoption of a Resolution.

NOW, THEREFORE, BE IT RESOLVED that the Band Assembly does hereby support the appointment of Rachel Shaugobay to represent the Band, as a member on the Minnesota Indian Child Welfare Advisory Council.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly, in Legislative Council assembled, a quorum of legislators being present, held on the 28th day of January, 2022, at Nayahshing, Minnesota, by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
