RESOLUTION 20-02-36-22

A RESOLUTION IN SUPPORT OF THE SHERBURNE COUNTY ACQUISITION OF FUTURE PARKLAND PROPERTIES THAT HOLDS SACRED CULTURAL MEANING TO THE OJIBWE CULTURE

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative body of the Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian tribe; and
- WHEREAS, pursuant to 3 MLBS §§ 3(d) and 3(f), the Band Assembly has the power to adopt resolutions to promote the general welfare of the people of the Band and to ratify agreements, contracts, cooperative and reciprocity agreements, and memoranda of understanding; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a "resolution" is defined as "a formal expression of the opinion, will, or intention" of the Band Assembly; and
- WHEREAS, the Band's Tribal Historic Preservation Office and Commissioner of Natural Resources have played a critical role in guiding Sherburne County on its acquisition of future parkland property ("Property") that holds sacred meaning to the Ojibwe Culture; and
- WHEREAS, the Property is also held sacred by the Dakota Culture; and
- WHEREAS, the County has demonstrated a strong desire to be culturally responsive and has adopted a spirit of inclusivity throughout the planning process; and
- WHEREAS, Sherburne County has deferred to the Band's cultural perspective as to how best respect the sacredness of the Property; and
- WHEREAS, Sherburne County has requested the Band's partnership on a Minnesota Historical Society Heritage Partnership Grant to conduct a Traditional Cultural Property Survey; and
- WHEREAS, the relationship that has developed stands in contrast to what the Band has experienced with other local units of government; and
- WHEREAS, the significance of a county and tribal government working cooperatively should be upheld and serve as a model for similar collaborative activities elsewhere.
