## **RESOLUTION 20-02-48-22**

## A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2023 CAPITAL BUDGET FOR GRAND CASINO MILLE LACS PROJECTS

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBS § 3(b) to appropriate all Band revenue regardless of source; and
- WHEREAS, the Band Assembly is also authorized under 3 MLBS § 3(d) to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on December 7, 2022, to open 2023 capital projects for Grand Casino Mille Lacs as follows:

Slot Product (M23-SLT-01) in the amount of: One million, four hundred fifty thousand dollars and no cents (\$1,450,000.00); and

Information Technology New Devices and Computer Growth Project (M23-SYS-01) in the amount of: Two hundred, fifty-six thousand dollars and no cents (\$256,000.00).

- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2023 Capital Budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 14<sup>th</sup> day of December, 2022, at Nayahshing, Minnesota, by a vote of <a>SILENT</a>. SILENT.
