## **RESOLUTION 20-01-25-22**

A RESOLUTION REPEALING AND REPLACING RESOLUTION 20-01-23-22 WHICH AUTHORIZED THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2022 CAPITAL BUDGET FOR GRAND CASINO MILLE LACS SURVEILLANCE – RECORDING MANAGEMENT CONVERSION AND HVAC UPGRADES PROJECTS

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBS § 3(b) to appropriate all Band revenue regardless of source; and
- WHEREAS, the Band Assembly is also authorized under 3 MLBS § 3(d) to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on May 30, 2022, to open a 2022 capital project for Surveillance Recording Management Conversion Project (M22-SUR-01) at Grand Casino Mille Lacs in the amount of three hundred forty-two thousand, seven hundred eighty-five dollars and no cents (\$342,785.00) and HVAC Upgrades Project (M22-PRO-02) at Grand Casino Mille Lacs in the amount of five hundred thousand dollars and no cents (\$500,000.00).
- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2022 Capital Budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 22<sup>nd</sup> day of June, 2022, at Nayahshing, Minnesota, by a vote of 3 FOR, AGAINST, SILENT.
