SPECIAL REVENUE RESOLUTION 20-02-05-22

A SPECIAL REVENUE RESOLUTION AUTHORIZING THE COMMISSIONER OF FINANCE TO SIGN THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE'S 401(k) RETIREMENT PLAN ADOPTION AGREEMENT FOR MERRILL LYNCH, PIERCE, FENNER & SMITH INC. NON-STANDARDIZED DEFINED CONTRIBUTION PREAPPROVED PLAN AND AN AMENDMENT TO IMPLEMENT HARDSHIP DISTRIBUTION PROVISIONS OF THE BIPARTISAN BUDGET ACT OF 2018

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian tribe; and
- WHEREAS, according to 3 MLBS § 3(d), the Band Assembly is empowered to adopt resolutions; and
- WHEREAS, according to 3 MLBS § 3(f), the Band Assembly is empowered to "ratify agreements, contracts, cooperative and reciprocity agreements and memoranda of understanding[;]" and
- WHEREAS, pursuant to 3 MLBS § 8(a), the Band's Secretary-Treasurer shall "superintend and manage all fiscal operations, planning and budgeting of the [Band] as authorized by the Band Assembly[;]" and
- WHEREAS, pursuant to 7 MLBS § 26(b)(4), "Band Assembly ratification is required for all contracts in excess of \$25,000.00[;]" and
- WHEREAS, pursuant to 22 MLBS § 102(a), any "direction to the Commissioner of Finance shall be promulgated" via a "Special Revenue Resolution" which shall contain the signatures of the "Speaker of the Assembly, two members of the Band Assembly and be concurred upon by the Chief Executive[;]"
- WHEREAS, approval has been received from the Internal Revenue Service ("IRS") for the Merrill Lynch Pre-Approved Plan documents updated for the Cycle 3 Restatement; and
- WHEREAS, the Band's 401(k) retirement plan ("Plan") is required to be restated onto the new Cycle 3 document so as to not jeopardize the plan's tax-qualified status; and

WE DO HEREBY CERTIFY that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly, in Legislative Council assembled, a quorum of legislators being present, held on the 20th day of July, 2022, at Nayahshing, Minnesota, by a vote of 3 FOR, 6 AGAINST, 6 SILENT.
