**A RESOLUTION CANCELLING RESOLUTION 12-01-125-06 FOR
MILLE LACS BAND MEMBER [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected legislative body of the Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian tribe; and

WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the power to adopt resolutions; and

WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and

WHEREAS, tribal land leases are required on all Band lands for agricultural purposes, to establish home sites or seasonal recreational residences, for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 12-01-125-06, dated July 18, 2006, authorized a residential land lease with an attached mortgage to Band Member [REDACTED]; and

WHEREAS, the land lease was to be for a period of 35 years and renewable for an additional 15 years, subject to the lease provisions, for the property described herein; and

WHEREAS, said land is described as follows:

Part of Tract #410T001001, located in the North One-half of the Northeast One-quarter (N½ of NE¼) of Section Twenty (20), Township Forty-three North (43N), Range Twenty-seven West (27W) Mille Lacs County, Fourth Principle Meridian, more particularly described as follows:

Lot Thirteen (13), Bugg Hill Plat[;]

and

WHEREAS, Band Member [REDACTED] has voluntarily relinquished the lease for the property described herein.
