RESOLUTION 20-04-41-23

A RESOLUTION APPROVING A LICENSE TO OPERATE WEWINABI, HEAD START AND EARLY HEAD START IN DISTRICTS I, II, AND III

- the Mille Lacs Band Assembly ("Band Assembly") is the duly elected legislative WHEREAS. body of the Mille Lacs Band of Ojibwe ("Band") a federally recognized Indian Tribe; and
- according to 3 MLBS § 3(d), the Band Assembly is empowered to adopt WHEREAS, resolutions: and
- according to 3 MLBS § 1(m), a resolution is defined as "a formal expression of WHEREAS, opinion, will, or intention voted on by the Band Assembly[;]" and
- WHEREAS, the licensing standards and procedures for all Band-Operated Child Care Centers operating on Band Lands is set forth pursuant to 8 MLBS §§ 946(d), and 954(a); and
- Mille Lacs Early Education, which operates child care centers in Districts I, II, WHEREAS, and III, possessed a license adopted via Resolution 20-02-40-22 which expires at midnight (12:00 AM) on October 1, 2023; and
- on September 19, 2023, the Mille Lacs Band of Ojibwe Child Care Licensing WHEREAS, Committee unanimously recommended continuing licensure of Wewinabi, Head Start, and Early Head Start in Districts I, II, and III; and
- the Licensing Committee submitted its recommendation to the Band Assembly on WHEREAS, September 25, 2023; and
- the District I Wewinabi Early Education has a capacity of Infants: 24-32; WHEREAS. Toddlers: 72-84; Preschool: 98; and School Age: 35; and
- WHEREAS, District II East Lake Early Education has a capacity of Infants/Toddlers: 16; and Preschool: 18; and
- WHEREAS, District III Lake Lena Early Education has a capacity of Infants/Toddlers: 8; and Preschool: 18.
