RESOLUTION 20-03-01-23

A RESOLUTION IN SUPPORT OF A MULTIJURISDICTIONAL SEX TRAFFICKING TASK FORCE MEMORANDUM OF UNDERSTANDING BETWEEN THE FOND DU LAC BAND OF LAKE SUPERIOR CHIPPEWA AND THE MILLE LACS BAND OF OJIBWE

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian tribe; and
- WHEREAS, pursuant to 3 MLBS §§ 3(d) and 3(f), the Band Assembly is empowered to “adopt resolutions” and “ratify agreements, contracts, cooperative and reciprocity agreements and memoranda of understanding;” and
- WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and
- WHEREAS, the Band wishes to enter into a Memorandum of Understanding (“MOU”) with the Fond du Lac Band of Lake Superior Chippewa who will be the lead agency and point of contract for the Tribes United Against Sex Trafficking (“TRUST”) Task Force and facilitate quarterly Task Force meetings throughout the state; and
- WHEREAS, the Band will be a partner in the project and commits to participate in the TRUST Task Force; and
- WHEREAS, the project has been approved and awarded by the Minnesota Department of Justice and the Fond du Lac Band serves as the fiscal agent.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby expresses its support for the Memorandum of Understanding between the Fond du Lac Band of Lake Superior Chippewa and Mille Lacs Band of Ojibwe.

WE DO HEREBY CERTIFY that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 10th day of January, 2023, at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
