**RESOLUTION 20-03-14-23**

**A RESOLUTION RATIFYING A COURT DATA SERVICES  
SUBSCRIBER AMENDMENT TO CRIMINAL JUSTICE DATA  
COMMUNICATIONS NETWORK AGREEMENT**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian tribe; and

WHEREAS, pursuant to 3 MLBS §§ 3(d) and 3(f), the Band Assembly is empowered to “adopt resolutions” and “ratify agreements, contracts, cooperative and reciprocity agreements and memoranda of understanding;” and

WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and

WHEREAS, the Band, acting through its Tribal Police Department, seeks to enter into a Court Data Services Subscriber Amendment (“Subscriber Amendment”) to the Criminal Justice Data Communications Network Agreement with the State of Minnesota, acting through its Department of Public Safety on behalf of the Bureau of Criminal Apprehension (“BCA”); and

WHEREAS, the Subscriber Amendment “modifies and supplements the Agreement between the BCA and [the Band’s Tribal Police Department], SWIFT Contract number 221580, of even or prior date, for [Tribal Police Department] use of BCA systems and tools[;]” and

WHEREAS, the Band’s Office of the Solicitor General has reviewed and sanctioned the substantive legal provisions of the Subscriber Amendment.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly does hereby ratify and lend its support to the Subscriber Amendment to modify and supplement the Agreement between the BCA and the Band’s Tribal Police Department, SWIFT Contract number 221580, of even or prior date, for Tribal Police Department use of BCA systems and tools.

WE DO HEREBY CERTIFY that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly, in Legislative Council assembled, a quorum of legislators being present, held on the 8<sup>th</sup> day of March, 2023, at Nayahshing, Minnesota, by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
