RESOLUTION 20-03-02-23

A RESOLUTION EXPRESSING SUPPORT FOR THE GRAND CASINO HINCKLEY AND GRAND CASINO MILLE LACS HOTEL REFRESH PROJECTS

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBS § 3(b) to appropriate all Band revenue regardless of source; and
- WHEREAS, the Band Assembly is also authorized under 3 MLBS § 3(d) to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and
- WHEREAS, during a Band Assembly meeting on January 4, 2023, Corporate Commissioner Joseph S. Nayquonabe formally requested approval of the Grand Casino Mille Lacs and Grand Casino Hinckley Hotel Refresh Project; and
- WHEREAS, Commissioner Nayquonabe also requested permission to work directly with the Commissioner of Finance to establish the financing plan.
- NOW, THEREFORE, BE IT RESOLVED, the Band Assembly hereby expresses its support for the Grand Casino Mille Lacs and Grand Casino Hinckley Hotel Refresh Project; and
- BE IT FURTHER RESOLVED, the Band Assembly expresses its support for Commissioner Towle to work directly with Commissioner Nayquonabe to establish the financing plan.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 10th day of January, 2023, at Nayahshing, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
