RESOLUTION 20-04-44-23

A RESOLUTION APPROVING THE CONTINUANCE OF THE MILLE LACS BAND GOVERNMENT, CIRCLE OF HEALTH, GAMING REGULATORY AUTHORITY, DEPARTMENT OF ATHLETIC REGULATION, SUPPLEMENTAL INCOME PROGRAM FOR ELDERS, TRIBAL EMPLOYMENT RIGHTS OFFICE, HOUSING INITIATIVE, AND BAND MEMBER LEGAL SERVICES FISCAL OPERATIONS UNTIL DECEMBER 31, 2023

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBS §§ 3(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source and adopt resolutions; and
- WHEREAS, 3 MLBS § 21 requires that all fiscal operations under the jurisdiction of the Band shall cease as of midnight on the last day of the biennium, unless the Band Assembly adopts a continuing resolution prior to such time; and
- WHEREAS, Ordinance 59-22, to fund the operations of the Band Government, Circle of Health, Gaming Regulatory Authority, Department of Athletic Regulation, Supplemental Income Program for Elders, Tribal Employment Rights Office, Housing Initiative, and Band Member Legal Services for Fiscal Years 2022 and 2023, expired September 30, 2023; and
- WHEREAS, the Band Assembly agrees to adopt a second (2nd) continuing resolution until December 31, 2023; and
- WHEREAS, the Band Assembly agrees that the effective date of this Resolution shall be November 1, 2023.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of Band Government, Circle of Health, Gaming Regulatory Authority, Department of Athletic Regulation, Supplemental Income Program for Elders, Tribal Employment Rights Office, Housing Initiative, and Band Member Legal Services fiscal operations until December 31, 2023; and
