RESOLUTION 20-03-09-23

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2023 CAPITAL BUDGET FOR GRAND CASINO HINCKLEY PROJECTS

- the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative WHEREAS. body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federallyrecognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBS § 3(b) to appropriate all Band revenue regardless of source; and
- WHEREAS, the Band Assembly is also authorized under 3 MLBS § 3(d) to adopt resolutions to promote the general welfare of the people of the Band; and
- Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested WHEREAS, approval on March 1, 2023, to open 2023 capital projects for Grand Casino Hinckley as follows:

Promotion and Club Advantage Lounge Project (H23-PRO-04) in the amount of: One million, one hundred ninety thousand, three hundred twenty-six dollars and no cents (\$1,190,326.00); and

Gold Room HVAC Project (H23-PRO-02) in the amount of: One million, two hundred thousand dollars and no cents (\$1,200,000.00).

- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2023 Capital Budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 8th day of March, 2023, at Nayahshing, Minnesota, by a vote of 3 FOR, O AGAINST, O SILENT.
