RESOLUTION 20-04-34-23

A RESOLUTION APPOVING THE COST SHARE AGREEMENT BETWEEN DUCKS UNLIMITED INCORPORATED AND MILLE LACS BAND OF OJIBWE FOR THE TWO ISLANDS WETLAND ENHANCEMENT PROJECT

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBS §§ 3(d) and 3(f), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band and to ratify agreements, contracts, cooperative and reciprocity agreements, and memoranda of understanding; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a "resolution" is defined as "a formal expression of the opinion, will, or intention" of the Band Assembly; and
- WHEREAS, as stated in 11 MLBSA \(\) \(\) \(\) the Band is committed to perpetuating commonly held traditional beliefs amongst American Indian people that human beings have a duty to peacefully co-exist within the natural environment, and that human beings further have a natural duty to protect the environment which provides humans beings with life-sustaining natural resources; and
- WHEREAS, the Mille Lacs Band of Ojibwe Department of Natural Resources is interested in water control structure wetland enhancement engineering and construction work to improve and correct obstruction or containment of an area of its wetland located in Morrison County, Minnesota; and
- WHEREAS, Ducks Unlimited among other things, conserves, restores, and manages wetlands and associated habitats for North American waterfowl, which also provides tangible benefits to other wildlife and to the environment.
- NOW THEREFORE BE IT RESOLVED that the Band Assembly hereby authorizes and approves the Mille Lacs Band Department of Natural Resources to support the wetlands enhancement project by entering into the Cost Share Agreement Between Ducks Unlimited Incorporated and the Mille Lacs Band of Ojibwe for the Two Islands Wetland Enhancement Project.
