## **RESOLUTION 20-03-10-23**

A RESOLUTION AUTHORIZING THE MILLE LACS CORPORATE VENTURES TO EXPEND FUNDS FROM FY2023 CAPITAL BUDGET FOR GRAND CASINO MILLE LACS PROJECTS

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly-elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly is authorized under 3 MLBS § 3(b) to appropriate all Band revenue regardless of source; and
- WHEREAS, the Band Assembly is also authorized under 3 MLBS § 3(d) to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, Joseph S. Nayquonabe, Commissioner of Corporate Affairs, formally requested approval on March 1, 2023, to open 2023 capital projects for Grand Casino Mille Lacs as follows:
  - Gaming Floor Carpet Replacement Project (M23-PRO-01) in the amount of: Six hundred thousand dollars and no cents (\$600,000.00); and
  - HVAC Unit Replacement Project (M23-PRO-02) in the amount of: Five hundred thousand dollars and no cents (\$500,000.00).
  - Recording Management Conversion Project (M23-SUR-01) in the amount of: Three hundred sixty-five thousand dollars and no cents (\$365,000.00)
- NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the Mille Lacs Corporate Ventures expenditure listed hereinabove from the 2023 Capital Budget.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 8<sup>th</sup> day of March, 2023, at Nayahshing, Minnesota, by a vote of 3 FOR, O AGAINST, O SILENT.
