RESOLUTION 21-01-21-24

A RESOLUTION ADOPTING AN UPDATED BUREAU OF INDIAN AFFAIRS 20-YEAR TRANSPORTATION PLAN (LONG-RANGE TRANSPORTATION PLAN, OR LRTP) AND UPDATED TRIBAL TRANSPORTATION SAFETY PLAN

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBS § 3 (d), the Band Assembly has the authority to adopt resolutions; and

WHEREAS, transportation planning is a contractible program of the Bureau of Indian Affairs under the provisions of the P.L. 93-638; and

WHEREAS, the Band, under the provisions of the P.L. 93-638, has contracted to conduct transportation planning activities; and

WHEREAS, in order to effectively use limited Tribal Transportation Program resources, the Band must provide the Bureau of Indian Affairs an updated 20-Year Transportation Plan (LRTP) and updated Tribal Transportation Safety Plan; and


WHEREAS, Band staff has updated the 20-Year Transportation Plan (LRTP) for 2024 and Tribal Transportation Safety Plan for 2024 and attached those plans to this Resolution.

NOW THEREFORE BE IT RESOLVED, the Band Assembly does hereby approve the 20-Year Transportation Plan (LRTP) for 2024 (Attachment A) as well as a Tribal Transportation Safety Plan for 2024 (Attachment B).

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly, in Legislative Council assembled, a quorum of legislators being present, held on the 5th day of June, 2024, at Nayahshing, Minnesota, by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
