RESOLUTION 21-02-44-24

A RESOLUTION APPROVING THE BAND'S 2025 MEMBERSHIP INTO THE INDIAN GAMING ASSOCIATION

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally recognized Indian tribe; and
- WHEREAS, pursuant to 3 MLBS §§ 3(d) and 3(f), the Band Assembly is empowered to "adopt resolutions" and "ratify agreements, contracts, cooperative and reciprocity agreements and memoranda of understanding;" and
- WHEREAS, pursuant to 3 MLBS § 1(m), a "resolution" is defined as "a formal expression of the opinion, will, or intention" of the Band Assembly; and
- WHEREAS, in a letter dated December 2, 2024, the Band's Chief Executive "recommend[ed] and request[ed] that the Band Assembly ratify and renew the Band's agreement to maintain its status as a member of the Indian Gaming Association"; and
- WHEREAS, the Band wishes to remain a member tribe in good standing with the Indian Gaming Association.
- NOW, THEREFORE, BE IT RESOLVED, that tribal funds in the amount of \$25,000.00 (Twenty-five thousand dollars and no cents), based on gross gaming revenue, and expended by Government Affairs, is authorized for payment for such membership in the Indian Gaming Association.
- BE IT FURTHER AND FINALLY RESOLVED, that the Band Assembly and Chief Executive do hereby authorize the following elected officials to fulfill their responsibilities as Official Delegates and Alternate Delegates to the Indian Gaming Association: Virgil Wind, Chief Executive; Sheldon Boyd, Secretary-Treasurer; Carolyn Beaulieu, District I Representative; Wendy Merrill, District II Representative; and Harry Davis, District III Representative.
