RESOLUTION 21-02-37-24

A RESOLUTION REPEALING AND REPLACING RESOLUTION 21-02-36-24 WHICH APPROVED A LICENSE TO OPERATE WEWINABI, HEAD START AND EARLY HEAD START IN DISTRICTS I, II, AND III

- WHEREAS, the Mille Lacs Band Assembly ("Band Assembly") is the duly elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally recognized Indian tribe; and
- WHEREAS, pursuant to 3 MLBS §§ 3(b) and (d), the Band Assembly has the authority to appropriate all Band revenue regardless of source and adopt resolutions; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a "resolution" is defined as "a formal expression of the opinion, will, or intention" of the Band Assembly; and
- WHEREAS, the licensing standards and procedures for all Band-Operated Child Care Centers operating on Band Lands is set forth pursuant to 8 MLBS §§ 946(d), and 954(a); and
- WHEREAS, Mille Lacs Early Education, which operates child care centers in Districts I, II, and III, possessed a license adopted via Resolution 21-02-30-24 which expired at midnight (12:00 AM) on October 1, 2024; and
- WHEREAS, on September 23, 2024, the Mille Lacs Band of Ojibwe Child Care Licensing Committee unanimously recommended continuing licensure of Wewinabi, Head Start, and Early Head Start in Districts I, II, and III; and
- WHEREAS, the Licensing Committee submitted its recommendation to the Band Assembly on September 30, 2024; and
- WHEREAS, the District I Wewinabi Early Education has a capacity of Infants: 24-32; Toddlers: 72-84; Preschool: 98; and School Age: 35; and
- WHEREAS, District II East Lake Early Education has a capacity of Infants: 8; Toddlers: 8; and Preschool: 18; and
- WHEREAS, District III Lake Lena Early Education has a capacity of Infants/Toddlers: 8; and Preschool: 18; and
- WHEREAS, District III Hinckley Early Education has a capacity of Infants/Toddlers: 24.
