RESOLUTION 21-02-32-24

A RESOLUTION RATIFYING THE REVOLVING LOAN POLICY

- the Mille Lacs Band Assembly ("Band Assembly") is the duly elected legislative WHEREAS. body for the Non-Removable Mille Lacs Band of Ojibwe ("Band"), a federally recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the authority to adopt resolutions; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a "resolution" is defined as "a formal expression of the opinion, will, or intention" of the Band Assembly; and
- WHEREAS, Band member employees need access to financial resources on reasonable terms; and
- WHEREAS, pursuant to 17 MLBS, Chapter 1, the Band government created a Revolving Loan program to meet this need, and the program is currently inactive; and
- WHEREAS, the Band Assembly wishes to reinstitute the program to support and improve the lives of Band member employees and their families; and
- on August 2, 2024, the Band Assembly adopted Act 43-24, which eliminated an WHEREAS. inefficient loan committee oversight system and relocating that program inside the Office of Management and Budget; and
- on August 8, 2024, Chief Executive Virgil Wind, a longtime advocate for the loan WHEREAS. program, signed Act 43-24 into law; and
- pursuant to 17 MLBS § 7, the Band Assembly must ratify the policies of the WHEREAS, Revolving Loan program; and
- the Band Assembly has reviewed and contributed to the proposed Revolving Loan WHEREAS, policies attached hereto and found them consistent with statute and in accordance with sound lending practices.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby ratifies the Revolving Loan policy.
